**PLEASE TAKE NOTICE** that the Minnesota Public Utilities Commission (Commission) will hold public hearings and evidentiary hearings on the route permit application of Summit Carbon Solutions, LLC (Summit) for a pipeline routing permit to construct the proposed Otter Tail to Wilkin Carbon Dioxide Pipeline Project. The project is an approximately 28.1 mile long, 4.5-inch outside diameter carbon steel pipeline and associated facilities that would transport captured carbon dioxide (CO<sub>2</sub>) from the Green Plains Ethanol Plant located near the city of Fergus Falls in Otter Tail County, Minnesota to the Minnesota—North Dakota border south of the city of Breckenridge in Wilkin County, Minnesota. Summit intends for the pipeline to connect to another proposed pipeline network in North Dakota which would transport the Minnesota-sourced CO<sub>2</sub> to permitted Class VI injection wells for sequestration in underground saline formations.

## Public Hearing Information

The Honorable Judge Moseng, Administrative Law Judge with the Office of Administrative Hearings, will preside over the public hearings and will provide a report to the Commission with findings of fact, conclusions of law, and a recommendation.

The purpose of the public hearings is to obtain public input on the proposed project. Interested persons will have the opportunity to: (1) ask questions of the applicant and agency staff; (2) offer oral and written comments on the merits of the proposed project; and (3) suggest possible conditions to be considered for inclusion in the pipeline routing permit.

- Comments received at the hearings and during the comment period will be used to inform the record and help the Commission with making its final decision.
- The information presented will be the same at all hearings.
- The hearings will end when all attendees have had the opportunity to comment and all other business has been concluded, or the scheduled end time of the hearing, whichever occurs first.
- Members of the public may participate without the necessity of intervening as a party; representation by legal counsel is permitted but not required.

Written comments will be accepted through **September 11, 2024, by 4:30 p.m.** Please include the docket number in all communications. Comments received after the close of the comment period may or may not be considered by the Commission.

Please focus your comments on information that will help answer the following questions:

- Should the Commission grant a pipeline route permit for the proposed Otter Tail to Wilkin Pipeline Project?
- If granted, what additional conditions or requirements should be considered for inclusion in the pipeline route permit?

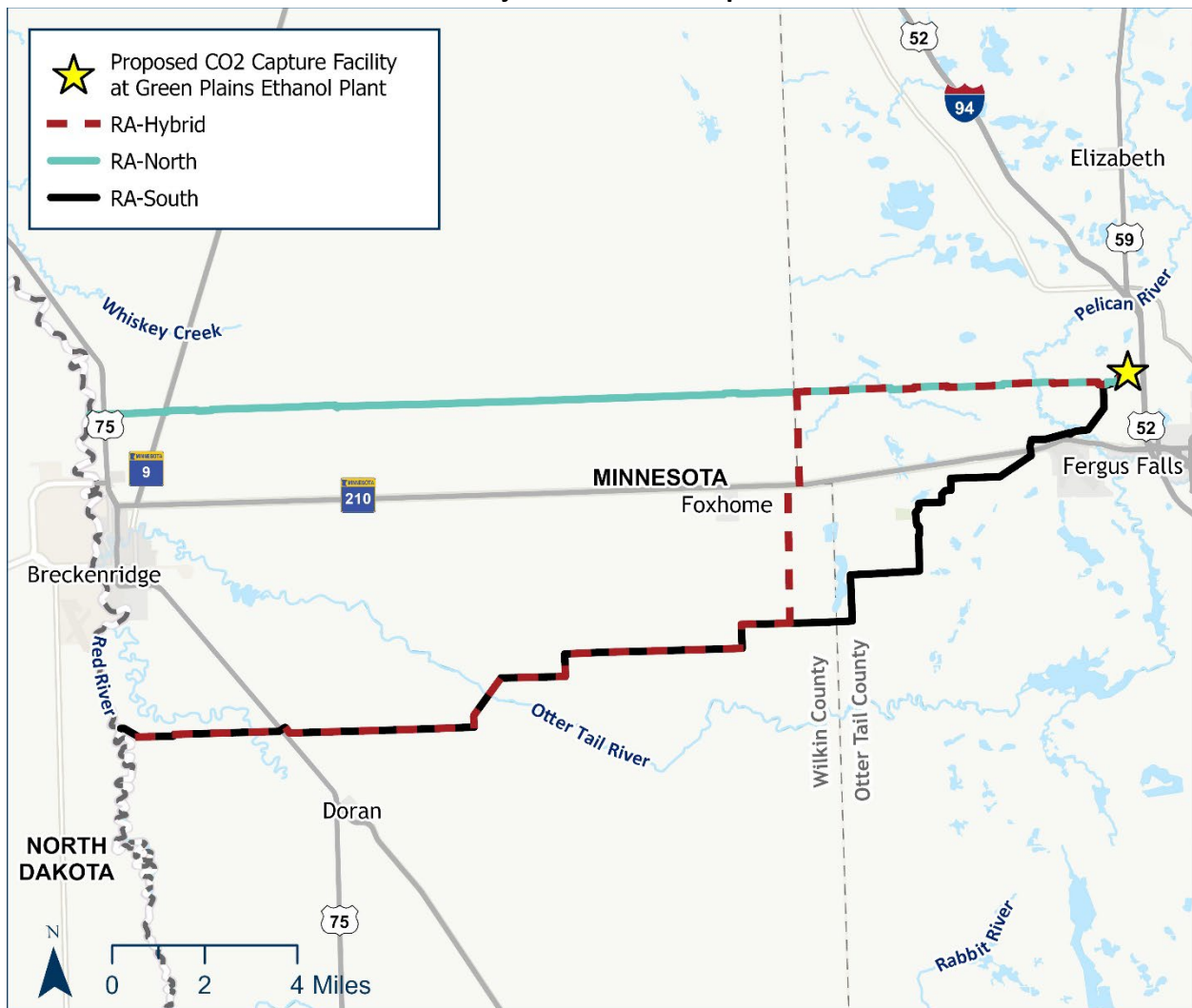
